3) The inspecting team along with the BDO of Umling found out that there was a plague in the wall of the building indicating Name of the Scheme, Year, Amount etc.

1) The inspection team found out that the Computerisation of Ri-Bhoi Presbyterian Higher Sec. School, Nongpoh was well organized and fully utilized by the students of the Secondary School.

2) It was also found out that there are altogether 32 (Thirty two) Computers, out of which 26 (Twenty six) were found to be in working condition and the remaining 6 (Six) were sent for servicing/repairs

3) As informed by the Principal of the School each computer cost around Rs.31,250/- and it was maintained by the Managing Committee.

4) The Principal was advised to fix a plaque on the wall of the Computer Room indicating the details viz, Name of MP, Year, Name of scheme, Amount sanctioned, date of completion, etc.

- (3) The Principal of the School has been advised to erect a signboard indicating the name of the Scheme, name of MP, date of sanction, amount sanctioned etc. in the side of the wall after the completion of the building.
