#### **Observations** :-

- (i) It is observed that a new big plot of forest land has been purchased by the Village Committee for the purpose of Construction of playground at Mulang, Nongbah at a cost of about Rs. 7,00,000/-
- (ii) It was found out that clearing / cutting of trees has been completed and only **a portion** of the actual work has just started.
- (iii) It was also informed that delay in starting the work is due to purchase of new plot of land and time taken for clearing/cutting of trees.
- (iv) The proposed size of the playground to be constructed is to be of standard size.
- (v) It was observed that there is no signboard mentioning the scheme.
- (vi) Though the actual work has just started but the quality and progress of work made is very satisfactory.
- (vii) On interaction with some people of the village they expressed great confidence that the project will be successful.

#### Recommendation

- (i) Since it is a big project regular monitoring of the progress of work of this project is required.
- (ii) A signboard should be erected at the site of the Playground.

Name of implementing/executing agency – The work is executed/implemented by the Managing Committee of the school.

#### **Observations:-**

- (i) It was observed that the estimate of the school building submitted was Rs. 11,80,700/-and hence the Managing Committee will have to bear the excess amount.
- (ii) The Secretary of Managing Committee had informed that the construction of the school building was constructed in memory of his grandfather 'Ieng Swer' who was also the Dolloi of the area in the past.
- (iii) It was found that the building is well maintained and all classrooms including benches and desks are in good condition.
- (iv) It was found that a portion of the construction work viz a room in the 1<sup>st</sup> Floor, toilet, washroom, corridor etc is yet to be completed.
- (v) The Secretary of the Managing Committee has assured that a signboard depicting the name of the schemes, name of MP Etc. will be erected after the construction is completed.
- (vi) It was found that the quality of construction of the school Building was very good and it appears that the fund was rightly used for the purpose.
