- 1. The development works include construction of a pump house for installing a water pumping machine with provision for accommodation of a Chowkidar cum pump operator having 3 rooms and also a toilet, construction of footpath at Lower Rynjah with a length of 85 metres and width of 1.80 metres and repair of RCC road at Rngi Rynjah which has a length of 95 metres and breadth of 2.90 metres.
- 2. The money has been well utilised since three important works have been done which have benefited the people of the locality.
- 3. The pump house has been constructed at the cost of Rs 4.30 lakhs, the footpath at Rs 1.20 lakhs and the repair of the RCC bridge cost Rs 50,000/-.
- 4. It was observed that in all the construction works, good quality materials were used and the works were well made and sturdy.
